





Planned Giving

It was a privilege to help Catholics throughout our diocese create numerous planned gifts in 2020 — all for the benefit of the Catholic Church as well as to meet their own personal needs.

We assisted more than 60 Catholics in creating *Charitable Gift Annuities* with the Foundation, all to benefit their favorite Catholic entity. Each of these donors were rewarded by enhanced tax benefits and, in some cases, a steady income stream for life. Nearly everyone was interested in a *Charitable Deferred Payment Gift Annuity*, which allowed them to also benefit from the amazing "Montana Endowment Tax Credit" (see sidebar). Some of these gifts and their tax benefits were maximized by giving appreciated stock rather than cash.

The Foundation was gratified to have received bequest gifts that were unexpected — what a wonderful thing for Catholics to do! Endowing one's annual gift to their church, by making a gift in their will, is an *everlasting* blessing. Still others who were of the qualifying age (70 ½) gave endowed gifts by wisely utilizing the IRA Charitable Rollover provision in 2020.

2021 and the Montana Endowment Tax Credit


I can make a gift to forever benefit my Church and get rewarded for it?

The State of Montana encourages Montana taxpayers to build the permanent endowments of their favorite charities by offering a whopping 40% tax credit for qualifying planned gifts! (A tax credit is *much* better than a tax deduction.) Hundreds of Catholics take advantage of this incentive to reassign their tax dollars to the Church each year. Doing the Hidden Work of the Church in the Year of Saint Joseph



Why do we begin Mary's month with the Feast of Saint Joseph the Worker on May 1st? First, as a means of sanctifying May Day (also known as Labor Day), but also, I believe, because celebrating Saint Joseph on May 1st showcases Saint Joseph as Mary's rock, guardian, and beloved spouse. The liturgical year is pointing directly to the fact that God has permitted his Church (of which the Virgin Mary is both sign and mother) — in all her power, beauty, and grace — to depend completely on Joseph's humble labors.

In His wisdom, God made this quiet man vital to salvation history, beginning with that domestic Church in Nazareth. St. Joseph's work was deeply hidden, even more so than it was for his Old

Testament namesake, Joseph son of Jacob, who skillfully governed the household of an Egyptian king. And yet, the responsory verse closing the Litany of St. Joseph assigns our carpenter the glory of the patriarchs by quoting Genesis 39: *He made him lord over his household, and prince over all his possessions*. Of course, the poor household that Saint Joseph served was infinitely more noble and significant than any royal court could ever be!

This has been a wonderful subject of meditation for me, having joined the Foundation's staff in the Year of St. Joseph, mere days before the Feast of St. Joseph the Worker! And as I learn more about our work, it has quickly become clear that St. Joseph is a perfect example and guide for the Foundation. Like him, we are doing the background work of the Church. We do not administer the Sacraments to the faithful, teach in Catholic schools, or directly serve the needy. That is the Church's work, and we all depend on it. But upon whom can the Church herself depend?

It's clear enough to our donors: Holy Church depends on us! Here at the Foundation, we unite with you in imitation of St. Joseph, whom Pope Francis calls a "daily, discreet, and hidden presence," offered to God in "love, placed at the service of the Messiah." Even though, as a public non-profit, we are a separate entity from the Diocese, we have been given the task of working with you to safeguard the Church's future in Eastern Montana (which, by the way, has two parishes dedicated to St. Joseph). As Ven. Pope Pius XII said, "If Joseph was so engaged, heart and soul, in protecting and providing for that little family at Nazareth, don't you think that now in heaven he is the same loving father and guardian of the whole Church, of all its members, as he was of its Head on earth?"

St. Joseph, Protector of Holy Church, pray for us!
